- The President & Chief Executive Officer is the primary ambassador and lead communicator of the organization and should develop strong relationships at the highest levels, generating support to advance the organization, its mission, and its brand.

- Develop strategic alliances with community leaders, program delivery partners, local officials, United Way Worldwide, and UWGMWC Board of Directors.

- Oversee organization's progress against the UWGMWC Strategic Plan and report annual progress on strategic goals to the UWMWC Board of Directors.
- Serve as chief UWGMWC culture ambassador. Provide leadership and direction for developing, maintaining, managing and protecting workforce.
- Evaluate performance of direct reports for compliance with established policies and pre-identified goals and objectives. Hold them accountable for continuous improvement of organization's services and efficiencies, and encourage them to take advantage of professional development through United Way Worldwide offerings.
